


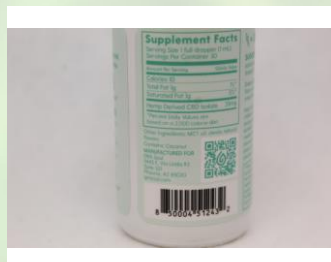

For values reported as "<LOQ", the estimated value is included in the calculated Total.
